As part of the Department of Home Affairs Student Visa requirements, Veritas Institute Australia is required to ensure that all prospective international students are genuine students committed to studying in Australia, and have the financial ability to pay for all costs whist studying in Australia.

About this Form

- This form is to assist in determining the level of interest you have in a preferred course or qualification. This form is an essential component in the visa process to ensure that that all prospective students are genuine in their intent to study in Australia.
- Assessment of the GTE provides a safeguard to ensure that only genuine applicants are granted a student visa and study in Australia.
- The GTE requirement considers whether the overall individual circumstances of an applicant indicate that their intention is for a temporary stay in Australia. Assessment of the GTE requirement takes into account a number of factors relating to an applicant such as their immigration history, circumstances that may encourage the applicant to return to their home country and circumstances that might encourage them to remain in Australia.
