



Course Delivery

A number of approaches to course delivery are used by Veritas Institute Australia. Course delivery approaches may include teacher-led classroom delivery; work-based training, practical placement training, simulated industrial kitchen training, workshops, practical's, seminars, tutorials and supervised study. During class time students will be expected to participate by answering questions, giving opinions, demonstrating tasks, working with others in groups, making presentations and participating in role playing situations.

Course Assessment

A number of approaches to course assessment are used by Veritas Institute Australia's staff. Assessment approaches may include observation of performance in class, practical demonstrations, workshops, undertaking case studies, projects, assignments, presentations, role plays, written tests or exams and work-based assessments.

Students are entitled for 2 free assessment attempts for each assessment task. If the student is unsuccessful after 2 assessment attempts, they will be required to repeat the unit and pay extra fee to finish the course or a unit of competency. Students are required to read Student Handbook for detailed information and fee & charges policy for more details.

Plagiarism

Acts of plagiarism, collusion & cheating are not permitted in any work completed for assessment & will result in a written warning & repeating the VET unit of competency, as well as incurring any associated charges. If a student is caught engaging in these acts a second time, they may be suspended or expelled from Veritas Institute Australia. All works submitted must be an accurate reflection of the student's level of competence. Qualification Recognition

Qualifications offered by Veritas Institute Australia are based on the principles, guidelines & standards set by Australian Qualifications Framework (AQF) & VET Quality Framework (VQF) & are nationally recognised.

Unique Student Identifier (USI)

All students undertaking vocational education and training must hold a Unique Student Identifier (USI) and provide it to Veritas Institute Australia during the enrolment process. If students do not provide USI, Veritas Institute Australia will not be able to issue a Certificate, Statement of Attainment or Transcript for the training. For details on USI visit www.usi.gov.au. Out Student Administration staff can assist you on how to obtain your USI on request.

Credit Transfers

Veritas Institute Australia accepts and provides credit to learners for units of competency and/or modules (unless licensing or regulatory requirements prevent this) where these are evidenced by:

- AQF certification documentation issued by any other RTO or AQF authorised issuing organisation, or
- Authenticated VET transcripts.

Credit Transfer for prior studies is limited to outcomes that are drawn from the national skills framework being units of competence awarded and accurately identified in statements of attainment and qualifications.

Recognition of Prior Learning (RPL)

Students who believe they already have some of the competencies in the course they wish to study may apply for RPL. An essential requirement of RPL is proof of competency. This may involve providing copies of your resume and/or work performance appraisals, job position descriptions and any certificates of in-house or formal training. Students may be asked for contact details of people who can vouch for your skill level such as supervisors from current or previous workplaces, clients, or personal character references from the community. Examples of other useful records include letters from employers and records of your professional development sessions. An application for RPL must be lodged in writing by completing Veritas Institute Australia's RPL Application Form available at www.veritas.edu.au

Qualifications Issued

Students completing all assessment requirements for a qualification will be awarded a certificate corresponding to the completed course. Students completing assessment requirements for part of a qualification will be awarded a Statement of Attainment for completed competencies. Completion of courses does not guarantee an employment or migration outcome. Formal requirements other than educational qualifications (e.g., licensing, professional registration etc.) may apply to some occupations and locations.

Change of Institution or Course

National Code of Practice for Providers of Education and Training to Overseas Students 2018 ("National Code 2018") restricts the capacity of students to transfer to other providers prior to completing six months of their principal course. Students who wish to apply for a permission to transfer to another institute must complete Veritas Institute Australia's Application for Letter of Release from available at www.veritas.edu.au. There is no cost associated with applying for a release; however, students must contact Department of Home Affairs to seek advice on whether a new visa is required. The reasons under which a student will be released are if:

- Veritas Institute Australia has cancelled/ceased to offer the students program (letter from Veritas Institute Australia supplied)
- the overseas student is reported because they are unable to achieve satisfactory course progress at the level they are studying, even after engaging with that registered provider's intervention strategy to assist the overseas student in accordance with National Code 2018 Standard 8
- there is evidence of compassionate or compelling circumstances
- Veritas Institute Australia has failed to deliver the course as outlined in the written agreement
- there is evidence that the overseas student's reasonable expectations about their current course are not being met
- there is evidence that the overseas student was misled by Veritas Institute Australia or an education or migration agent, regarding Veritas Institute Australia or its course, and the course is therefore unsuitable to their needs and/or study objectives

All applications will be assessed on the basis of Veritas Institute Australia's policies including Enrolment Procedure, and Fees Payment and Refund Policy (International Students) (available at www.veritas.edu.au) and the study plan and declaration submitted by the student in their application. Documented evidence supporting circumstances/reasons for seeking a release letter must be included with this application. If students wish to change their course at Veritas Institute Australia after receiving their Confirmation of Enrolment (CoE), they will be required to pay a Change of CoE administration fee of \$200.

Pre-enrolment Assessment

Selection for enrolment in our courses will be approved for applicants who meet the qualification admission criteria via Preenrolment survey and a brief interview prior to the confirmation of enrolment at Veritas Institute Australia. This is to ensure that the student has relevant skills required to undertake and successfully complete the qualification within the time-frame specified on electronic confirmation of enrolment (eCoE). All international learners will undertake pre-training review which aims to identify their training needs through questions on previous education or training, relevance of the courses to learner, relevant experience and interview conducted by Veritas Institute's enrolment officer. Interview also aims to identify any support needs and possible RPL opportunities. Through pre-training review learner will demonstrate that they have necessary skills to successfully complete the course

Age Requirements

All students must be aged 18 years or over at the time of course commencement.

Academic Requirements

Satisfactory completion of a minimum of Australian Year 12 or equivalent education is required for entry into any course at Veritas Institute Australia.

English Requirements

International learners applying for any course except BSB80120 Graduate Diploma of Management (Learning) either off-shore or on-shore will require a minimum IELTS (Academic) test score of 5.5 or equivalent for direct entry, or IELTS score of 4.5 or equivalent with an ELICOS course (up to 30 weeks) to be taken before the main VET course plus successful completion of Veritas Institute's LLN Test on completion of ELICOS program. For BSB80120 Graduate Diploma of Management (Learning) program, international learners either offshore or on-shore will require a minimum IELTS (Academic) test score of 6.0 or equivalent for direct entry. Direct entry is also available on successful completion of

Veritas Institute Australia's English Placement Test. Results older than two years are not acceptable. Please note: Veritas Institute Australia will also accept equivalent test results from TOEFL IBT, PTE Academic, Cambridge English: Advanced (CAE) and TOEFL PBT.

English Exemption

Students will be exempt to provide evidence of English Language test if they have evidence that they have studied in English for at least five years in Australia, Canada, New Zealand, Republic of Ireland, South Africa, United Kingdom or United States or evidence that, within two years of their application date, they have successfully completed in Australia a foundation course or a senior secondary certificate of education or a substantial part(50%) of a Certificate IV or higher-level qualification, from the Australian Qualifications Framework.

Language, Literacy and Numeracy Requirements

Candidate undertaking a VET course at Veritas Institute Australia must possess sound LLN skills since it requires them to do calculations, read recipe cards, prepare financial reports, make budgets and do menu costing etc.

All students are required to undertake a language, literacy and numeracy (LLN) test mapped at the following ACSF levels for various courses conducted by Veritas Institute.

If learners do not meet LLN requirements, they will be asked to take further Language, literacy and numeracy training e.g. Special classes with their trainers before the start of their usual class. Trainers will organise & conduct special activities for students who do not meet LLN requirements. A re-assessment of the LLN will be conducted prior to beginning the second term to assess the student's improvements or deficiencies in LLN. The process will be repeated by trainers to ensure students are brought up to the required LLN level before the proposed completion date of their course.

Computer Literacy Requirements

All learners enrolling in our programs must have basic computer skills and have a working understanding of a Computer/laptop, Internet,

Word processing, spread sheet & presentation software such as MS Office Suite.

- Software to view online videos & images such as Adobe reader, Windows Media Player, Windows Photo Viewer
- Digital video recording device and/or digital camera and associated software to save ad upload video and image files. Many mobile phone and smart phones include this technology
- Office equipment & resources such as telephone, photocopier, scanner & printer (e.g. office equipment is used by students in a simulated environment whereby students will undertake role plays tapping business meetings, conferences, online conference, board room meetings)

Students will be completing a pre-enrolment survey that will allow us to know about your computer skills in advance. Students who do not possess basic computing skills will be referred to a basic computer skills course e.g. International Computer Driving License (ICDL) which can be taken at any centre/institute of the students choosing either in their home country or Australia at their own cost. Materials & Equipment Required

Although Veritas Institute Australia will provide access to computers/laptops with the required resources including access to internet during classroom hours, to work on assignments and tasks for self-study, all learners are expected to have access to a laptop or computer with the Windows 7 operating system or higher at their own cost. Students must have an active email address for communication and be contactable by phone (mobile or landline) and by mail (postal address).

Some courses also have physical and equipment requirements as follows:

Hospitality Courses at Veritas Institute Australia

i.Tools and equipment

Learners are expected to have access to a kitchen tool kit. Veritas Institute Australia 's kitchen has knives etc. for students to use, however, students are required to purchase a chef's uniform and safety boots at their own cost. These can be sourced from Veritas Institute Australia's nominated supplier. These are required by students in order to undergo the training effectively.

ii. Physical Abilities and the handling of

food Learners are expected to have physical ability required to perform the tasks undertaken while undergoing training. As part of this course learners, are expected to handle foods including various processed or raw meats, poultry, seafood's, dairy items etc. Veritas Institute Australia will endeavour to take into account religious rules observed by the student, but the student must be aware of the possibility of handling such foods before enrolling in this course. In line with its access and equity policy, Veritas Institute Australia will identify any such barriers presented by students during pre-training review process before enrolment and will identify and provide required support and reasonable adjustment where possible.

Work Experience Evidence Information for BSB60420 Advanced Diploma of Leadership and Management

For entry in to the qualification BSB60420 Advanced Diploma of Leadership and Management, applicants who have not completed a Diploma or Advanced Diploma from the BSB Training Package (current or superseded equivalent versions) will need to substantiate evidence of two years equivalent full-time relevant workplace experience in an operational or leadership role in an enterprise. This experience must be in full time (at least 38 hours or week) paid employment.

What is Full Time Paid employment is defined to mean 'engaged in an occupation for remuneration for at least 38 hours a week.'

What is Remuneration: For 'remuneration', the intention is that applicants have been engaged in the occupation on a paid basis. Mere emotional or psychological satisfaction or the acquisition of useful, but unpaid, professional experience is not considered 'remuneration' for admission purposes. A person receiving minimal living allowances or scholarships designed to cover expenses would not be considered to be remunerated.

What is being remunerated at least 38 hours a week: Working for at least 38 hours a week means 38 hours each week generally. However, where employment contracts provide for variable distribution of hours of work that extend beyond a week such as some shift workers, "fly in fly out" workers and seafarers, this can be taken into consideration in determining whether a person has worked 'at least 38 hours per week.'

What about leave periods: As employment must be for remuneration, only periods of leave on full pay may be counted as time during which an applicant was employed. That means those periods of extended leave without pay (for example, maternity or paternity leave) might not be counted as a period of employment.

What kind of Evidence of Work experience should you provide: To evidence claims, applicants may be asked to provide detailed evidence of their terms of employment and salary payments. Evidence of work experience must include documents that show the period of employment, the employer's name, and remuneration received (hourly or monthly) and the position held. Evidence of work experience includes but is not limited to original or certified copies of the following documents:

- references from employers,
 - · on company letterhead, and
 - stating the occupation, remuneration and dates of employment, and
 - giving the contact phone number and address of the employer
- letters of appointment along with relieving letters indicating period of employment
- certificates of service
- pay slips for at least 12 months for the 24-month employment period with 1st month and last month's pay slips
- job specifications
- tax records
- job assessments.

If documents submitted as evidence of work experience do not show the relevance of the work experience to the qualification, applicants may have to provide further evidence of the relevance of the work experience.

Operational or leadership Role means but is not limited to engaging in any business activity as a full-time employee of a company that involves the direct management, supervision or performance of the ongoing development, production, marketing, sales or service of and for technologies, products or services. Examples include but not limited to Supervisors, Managers, Product Specialists, Marketing Managers, Business Unit heads, Team leaders, Etc.

Enterprise: For the purpose of this qualification, an enterprise can be a public company, private company, and partnership concern, government institution, not for profit or for-profit organisation, trust but not a sole proprietorship. Such institution or organisation must be registered under an Act or legislation where it operates.

What is WBT

Full Time Study

Australian law requires international students to undertake a full-time study load is normally a minimum of 20 hours per week for at least 40 weeks each calendar year or continuous 12-month period.

Attendance

students International studying VET courses are expected to attend all classes. However, students in VET courses will be reported to Department of Home Affairs only on the basis unsatisfactory course progress (see Academic Progress). Reporting a student to Department of Home Affairs will to result in the cancellation of the student's Confirmation of Enrolment (CoE) and the possible cancellation of their student visa.

Academic Progress

If students do not make satisfactory academic progress, they will be reported to Department of Home Affairs which may lead to cancellation of their visa. Unsatisfactory academic progress is defined as failing more than 50% of units in the same course in any two consecutive study periods (one study period equals one term). A failure in more than 50% of units in one study period will trigger a review of academic progress by Veritas Institute Australia and the implementation of an intervention strategy. Failing a unit means being assessed as 'Not Yet Competent (NYC)' for a completed unit. In order to have the best chance of maintaining satisfactory progress students must:

- Attend all theory and practical classes
- Pay attention to the work and activities undertaken in class
- Stud the theory and practice the skills that are taught in class
- Ensure that you are present for all assessment activities scheduled by trainers
- Make an appointment with the Student Support Officer if you are having any difficulties with your studies.

In addition to the above minimum requirements, Veritas Institute Australia will implement counselling procedures and an intervention strategy when students' trainers think that they may be in danger of not meeting the requirements. Counselling and intervention may be conducted more frequently. If students fail to meet the requirements of satisfactory course progress, they will be reported to Department of Home Affairs. Living in Australia

Multiculturalism

Australia is one of the world's most culturally diverse countries. Australia's dvnamic multiculturalism can be attributed to its unique combination of indigenous cultures, early European settlement and immigration from all parts of the world. Australians value the wealth of cultural diversity and social sophistication that international students bring to its campuses and communities. Veritas Institute Australia takes great care in looking after international students and helping them to adjust to the Australian way of life. International students also gain great benefits from their education in Australia and make lifelong friendships.

Language

Although English is the official language, more than 20 per cent of Australians speak a language other than English. English, as it is spoken in Australia, is easily understood by nearly all people from other English-speaking nations. While there are some minor differences in accent between the cities and country areas, the differences are much less than those found in America, Britain and Canada. As students improve their English, they will learn some of Australia's colourful and often humorous slang, and have fun explaining the meanings to friends and relatives.

Religion

Australia is predominantly a Christian country; however, all religions are represented. Australians respect the freedom of people to practice their choice of religion. Churches, mosques, temples and synagogues are located in most major cities.

Healthcare

Australia has a very good healthcare system. All Australians pay a Medicare levy (additional tax) to fund the public health system to ensure that everyone has access to public-system doctors, hospitals and other healthcare services. People who pay extra into private health insurance funds receive extra privileges when using private healthcare services. Students will find the usual healthcare services available in Australian suburbs including general practitioners (GPs) (medical doctors), dentists, osteopaths, chiropractors, psychologists, counsellors and many complementary healthcare practitioners such as traditional Chinese medicine. naturopathy. acupuncture, kinesiology etc. International students studying in Australia are required to have Overseas Student Health Cover (OSHC) for the duration of their student visa (see Overseas Student Health Cover in this section).

Budgeting

Food

Australia has a fantastic variety of food. Its top-quality meat, fish, fruits and vegetables are exported to markets worldwide. There is a large range of fruit and vegetables available at Australian produce markets. Students should have no difficulty finding the foods that they are used to at home. Students can sample almost every type of cuisine in Australia's many restaurants and cafés. Ethnic restaurants offer cuisines from all around the world. Good food at reasonable prices can be found at bistros, cafés and pubs. For those who like takeaway, most of the major global fast-food chains are well represented. The adventurous might want to sample Australia's bush tucker and national specialties like kangaroo (available in supermarkets) and crocodile (available in some restaurants).

Sports and Recreation

Australians are very keen on sport and outdoor activities and have gained a worldwide reputation as tough competitors in individual and team sporting events. Australia has over 100 national sporting organisations and thousands of state and regional sporting bodies. Australians are also enthusiastic about bushwalking, fishing, boating and water sports.

Money and Banks

The Australian Dollars (AUD) is the legal tender in Australia. When students first arrive, money from other countries can be changed at the exchange facilities located at international airports, banks and major hotels. Travellers' cheques are easier to use if already in Australian dollars, however, banks will cash travellers' cheques in virtually, any currency. Major hotels and some shops, depending on individual store policy, will also cash travellers' cheques. It is a good idea to set up an Australian bank account. Students will need to provide visa details and evidence of residency. Banking services in Australia are extremely competitive. All major banks have branches in cities and regional centres. Major banks include ANZ, Westpac, National Bank and Commonwealth Bank. Community banks, like Bendigo Bank, are a popular alternative. Most shopping centres have Automatic Teller Machines (ATM) facilities. These machines can be used for deposits and, in many instances, withdrawals 24 hours a day.

Normal Bank Trading Hours

Mondays to Thursdays - 9.30am - 4.00pm Fridays - 9.30am - 5.00pm Some banks are open Saturday mornings.

Credit Cards

Credit cards are widely accepted around Australia. The most commonly accepted credit cards are Visa and Master Card. Currency Australia uses a dollars and cents system of decimal currency with 100 cents in a dollar. The bank notes in use are \$5, \$10, \$20, \$50 and \$100. Coins used are the silver-coloured 5 cent, 10 cent, 20 cent and 50 cent coins and the gold-coloured \$1 and \$2 coins.

Tipping

Tipping is not the general custom in Australia and service charges are not added to accounts by hotels and restaurants. In good quality restaurants however, it is usual to tip food and drink waiters up to 10% of the bill for good service. Porters have set charges at railway terminals, but not at hotels. However, tipping is a matter of individual choice.

Transport

Australia has an extensive public transport system that includes trains, buses, tramways, ferries, two major national airlines and a number of regional airlines. See Living in Geelong page. Driving: Tourist students may drive in Australia on a valid overseas driver's licence, but if the document is not in English, the visitor must carry a translation with the permit. An international driver's licence alone is not sufficient.

Taxis: Metered taxicabs operate in all major cities and towns. Students can find taxi ranks at transport terminals, main hotels or shopping centres or can hail taxis in the street. A light and sign on the roof indicate if a taxi is vacant. There is a minimum charge on hiring and then a charge per kilometre travelled. Students do not need to tip taxi drivers.

Telephones

Australia has a modern telecommunications system with mobile and internet access generally available at low cost. Public telephones are run by Australia's largest telecommunications company, Telstra, and are available at all post offices, shopping centres and are often situated on street corners. Telstra public pay phones accept a variety of coins and Telstra phonecards. Phonecards are pre-paid for use in public pay phones and can be bought at a large number of

Students should work out a budget that covers accommodation, food, transport, clothing and entertainment. Childcare, if applicable, should also be taken into account

Electricity

The electrical current in Australia is 240/250 volts AC, 50 cycles. The Australian three-pin plug is absolutely safe. Adaptors are usually required for most foreign appliances. A transformer may be required if students bring an appliance from overseas that operates on a different voltage.

department stores, supermarkets and specialist shops have electronic transfer terminals (EFTPOS) where cash withdrawals can also be made in addition to purchasing goods.

retail outlets such as post offices and newsagents in denominations of \$5, \$10, \$20 and \$50. Credit phones take most major credit cards such as Visa and Mastercard and can be found at international and domestic airports, central city locations and hotels. Mobile phones are very popular and can be purchased from a number of retailers. A local call from a payphone costs \$0.50c. Calls interstate (STD) cost between \$0.50c and \$0.75c per minute. Calls to mobiles cost \$1 per minute.

Living in Australia

Travel

During term breaks, students may like to venture beyond Geelong to experience more of Australia's spectacular natural environment and great physical beauty, such as its marine and national parks including The Great Barrier Reef, Kakadu, Uluru, Queensland rainforests and the pristine countryside mountains of Tasmania. Student and backpacker travel agents in metropolitan cities offer cheap flights and package deals.

Finding Accommodation

The following types of accommodation are available for international students.

Home Stay

This option is opportunity for students to live in a private home, with a local family, couple or single person and learn about Australian life. Students may need to compromise with living arrangements as students will need to fit in with the household's routines and expectations. Students will need to think about the things that are important to them. Students may need to ask about how adaptable meal times are in relation to your studies and other commitments. Students may also want to consider how other people will feel their friends about visiting, their music and the hours that students keep. There are different types of home stay

Half Board

Half board usually includes a furnished room (bed, desk, lamp, wardrobe) and bills (electricity, gas and water. but not telephone and internet). Students have the use of the cooking and laundry facilities in the house. Board in Exchange: Board in exchange usually means free, or low cost, accommodation

(including bills), in return for household duties such as cleaning, or childcare.

Lease/Rent

Renting an apartment or house is done through a real estate agent. Students must sign a contract called a "lease" to rent the house, either month-bymonth, or sometimes a 6-month, 12-month or 2-year lease is required. The lease entitles tenants to private use of the property for the duration of the lease. The advantage of this is privacy independence. Students must pay a bond (the equivalent of month's rent, to cover any damage they may do to the premises). Students responsible for paying all bills (except water and council rates), maintenance of the property and providing all their own furniture and household items. If students choose a house or apartment in a

popular area, there will be much competition.

Cost of Living

Australia is a sophisticated, friendly country that enjoys one of the highest standards of living in the world. Students will need a minimum of AU \$21,041 per year (excluding tuition) to cover living expenses such as accommodation, food, clothing, entertainment, transport, international and domestic travel and other incidental costs. The cost of living, however, depends a lot on the kind of accommodation a student chooses. A married student with a partner coming to Australia will need approximately an additional AU \$7,362 per year and student with a child coming to Australia will need an additional AU \$3,152 per year. Below is a price table of typical daily items. This is only a guide. Remember that you can shop around for items, such as clothing and shoes, to find a cheaper source. Geelong is a port city located on Corio Bay and River. the state of Victoria, Australia. Geelong is 75 kilometres (47 mi) south-west of the state capital, Melbourne. It is the second largest Victorian city, with an estimated urban population of 268,277 as of June 2018. Geelong runs from the plains of Lara in the north to the rolling hills of Waurn Ponds to the south, with Corio Bay to the east and the Barrabool Hills to the west. Geelong is the administrative centre for the City of Greater Geelong municipality, which covers urban, rural and coastal areas surrounding the city, including the Bellarine Peninsula.

Geelong was named in 1827, with the name derived from the local Wathaurong Aboriginal name the region, Djillong, thought to mean "land" or "cliffs" or "tongue of land or peninsula". Geelong City is also known as the 'Gateway City' due to its central location to surrounding Victorian regional centres like Ballarat in the

north west, Torquay, Great Ocean Road and Warrnambool in the southwest, Hamilton, Colac and Winchelsea to the west, and the state capital of Melbourne in the north east.

The area was first surveyed in 1838, three weeks after Melbourne. The post office was open by June 1840 (the second to open in the Port Phillip District). The first wool store was erected in this period and it became the port for the wool industry of the Western District. During the gold rush, Geelong experienced a brief boom as the main port to the rich goldfields of the Ballarat district. The city then diversified into manufacturing, and during the 1860s, it became one of the largest manufacturing centres in Australia with its wool mills, ropeworks, and paper mills

It was proclaimed a city in 1910, with industrial growth from this time until the 1960s establishing the city as a manufacturing centre for the state, and the population grew to over 100,000 by the mid-1960s. During the city's early years, an inhabitant of Geelong was often known as a Geelongite, or a Pivotonian, derived from the city's nickname of "The Pivot", referencing the city's role as a shipping and rail hub for the area. Population increases over the last decade were due to growth in service industries, as the manufacturing sector has declined. Redevelopment of the inner city has occurred since the 1990s, as well as gentrification of inner suburbs, and currently has a population growth rate higher than the national average.

Today, Geelong stands as an emerging health, education and advanced manufacturing hub. The city's economy is shifting quickly and despite experiencing the drawbacks of losing much of its heavy manufacturing, it is seeing much growth in other sectors, positioning itself as one of the leading non-capital Australian cities.

Admission Process

Step 1
